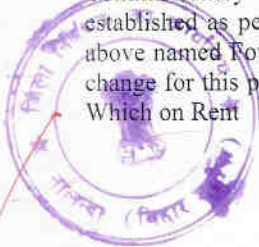

the students and also to the member of the society.

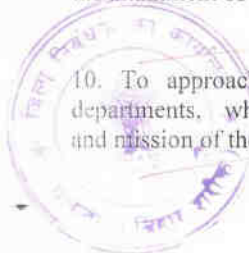
6. To engage, employ or hire appropriate staffs, teachers,

16. To make case studies and data collection both in general and particular among the deprived sections.

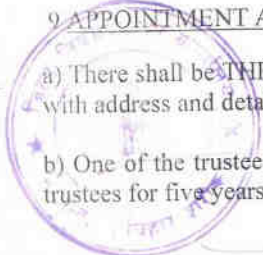
17. To cause and undertake such other activities which are incidental or conducive to the attainment of the vision/mission of the trust.

18. All the incomes/ earnings, movable/ immovable properties of the society shall be solely utilized and applied towards the promotion of its aims and objects only as set forth here in the trust deed itself. And no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner what so ever to the present or future member Or trustees or to any person aiming through anyone or more of the present or future trustees. No trustee of this trust shall have any personal claim on any movable or immovable properties of the trust or make any profits, whatsoever, by virtue of being trustee.

9. APPOINTMENT AND TENURE OF THE TRUSTEE

a) There shall be THREE Trustees as mentioned herein above with address and details.

b) One of the trustees shall be the Chairman of the Board of trustees for five years.

c) Any Trustees who is declared as an uncharged insolvent or being of unsound mind shall cease to be a Trustee.

d) In the event of there being any difference of opinion among the Trustees, the decision of the Author/Settler shall be final.

e) The Trustees shall always be guided and shall be bound by all instructions and directions which may be issued from time to time in regard to the affairs of the Trust by the Author/Settler.

10 VACANCY OR IRREGULARITY IN APPOINTMENT NOT TO INVALIDATE ACTION:

No vacancy on the Board of Trustees and no irregularity in the appointment of any Trustees shall invalidate any action or decision taken by the Board of Trustees

11. SPECIAL FEATURES OF THE TRUST:

a) The individual in interest to outsource support through consortium / agency / trust / N.G.O.'s / V.O. / any organization registered as per Section -25 of the Companies Act / Company, as per vision, goal and mission of the instant trust would be given an opportunity as decided by Board of the trustee for the sake of trust and accordingly such interested individual would establish infrastructure and thus would percolate the scope/ambit of the trust

b) The board of trustee may appoint one or more advisory boards, executive committee or any such bodies for efficient formulation and effective implementation of specific projects or tasks, that is called Advisory Boards and tenure of such board/body/committee would be in general case one year but if the members are found indulged in such activities prejudicial to the interest of the trust, the same would cease automatically in addition to insolvency, insanity

c) MEMBERSHIP:

There would be three types of membership, one as active member second as associate member and third as honorary member.

i. To be active member of the trust the individual desirous shall submit application with his/her address proof in the head office or the local office of the trust and for this a token amount of Member Disided is required to be contributed/donated by way of Cheque/Cash with the trust and the amount as decided by the board of the trustee time to time would be informed accordingly.

ii. To be an associate member the individual desirous is bound to serve the trust free of cost alike volunteer at least one month, yearly as and when required by the board of the trustee and alike the active member subscription with address proof is required to be furnished either in the Head Office or Local Office of the Trust However such an associate member is required to donate a sum of Member Decided by way of cheque / draft / cash for which a certificate of donation would be issued after due performance as per the vision of the trust More over such associate members are only eligible to be appointed as members in the Advisory Board of The Trust

iii. To be an honorary member the individual desirous is required to donate an amount of either Member Disied or above by way of Draft/Cheque only. Such an honorary member in association with other such members would form District Level Advisory Board/Committee as per vision/Goal/Mission/object of the Trust.

12. PROJECT ORIENTATION

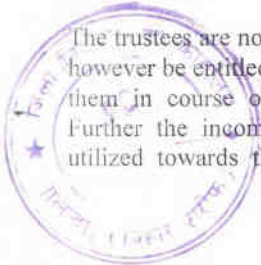

13. SUITS:

The managing trustee of the trust is authorized to Sue or to be sued on behalf of the Trust

14. HONOURARIUM OF THE TRUSTEE:

The trustees are not entitled for any honorarium but they shall however be entitled to meet out day to day returns incurred by them in course of discharging the functions of the trust. Further the income and funds of the trust will be solely utilized towards the objects and no portion of. it will be

15. SOURCE OF THE INCOME OF THE TRUST:

- a) Donations from individuals, companies, trust! foundation, Government foreign agencies and charity cash box etc.
- b) Interest/dividends on short/long term investment.
- c) Usually prepared by beneficiaries of the Trust.
- d) Rent, if the trust leases out its property like office space, hail etc. Membership subscription /donation.

16. ACTIVITY OF THE TRUST:

The Activities of the Trust shall be only within India and its Union territories.

17. VOLUNTARY CONTRIBUITION:

a) It is expected that an individual is to provide service to achieve the vision/goal/mission of the trust voluntarily without remuneration and such person of the Land of Bharat is designated as "Hon'ble member" of the trust.

b) To receive voluntary contribution from any person or persons from India or outside, after complying with the statutory formalities.

18. POWERS OF THE TRUSTEES:

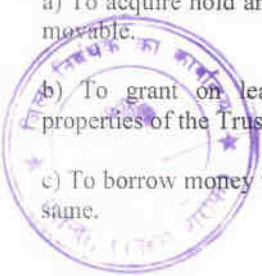
The Board of Trustees shall have full power and authority to administer the Trust, its institutions, properties and funds and to do all acts, deeds and things as are assessed to provide the objects for which this Trust is established.

Without prejudice to the generality of the foregoing, the Board of Trustees shall have power and authority for the purpose of the Trust.

a) To acquire hold and dispose of properties- immovable and movable.

c) To borrow money with or without security and to repay the same.

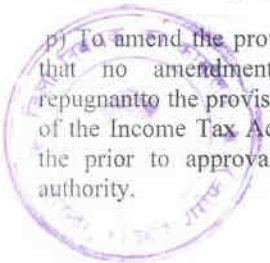

- d) To enter into contracts, vary and rescind it
- e) To open Bank Accounts/and provide for operation thereon as the Trustees may deem fit from time to time.
- f) To invest the funds of the Trust not immediately required for the purpose of the Trust in such manner as they deem fit subject however to the provisions of Sections 13(1) (d) read with Section 11(5) and 13(5) of the Income Tax Act 1961.
- g) To receive gifts, grants, endowments and donations in cash or kind.
- h) To accept donations and collect subscriptions.
- i) To institute, prosecute and defend all suits legal and other proceedings and appoint agents, lawyers and accountants.
- j) To appear and act before Courts, Tribunals, Governmental Municipal, Tax and other Public or local authorities.
- k) To appoint, terminate, dismiss, suspend and otherwise deal with the consultant of the Trust and its institutions and projects.
- l) To apply the properties and funds of the Trust for all or any of the objects for which the Trust is established as may be determined by the Board of Trustees, from time to time.
- m) To enter into arrangements, amalgamation with any other association, institution, society or Trust having similar objects of this Trust
- n) To decide from time to time the works to be undertaken in fulfillment the objects of the Trust
- o) To incur all necessary expenses connected with the Trust, its institutions and projects.
- p) To amend the provisions of this Deed of Trust provided that no amendment will be made which may be repugnant to the provisions of Section 2(15), 11 to 13 and 80-G of the Income Tax Act, 1961. All amendments shall be with the prior to approval of the jurisdiction of Income Tax authority.

The Secretary shall deal with correspondences on behalf of the trust, send replies in consultation with the Managing Trustee, and / or the Author/Settler where necessary. He/she is responsible for the safe custody of all the properties and records of the Trust. The secretary shall represent the Trust in all legal matters, sign the papers related to legal cases, attend to courts or represent the Trust in Government offices as much as possible and in exigency the special conferment upon any other individual who is member of the trust maybe made for a special case with certain period and time.

Under Role of Treasurer

The Treasurer will prepare Annual Budget monthly and yearly expenditure statements, and got the expenditure audited by auditor duly appointed by the Board of Trustees and place them before the Board of Trustees for approval. The Treasurer is responsible to maintain cash book and Prepare vouchers for the payments made, receive contributions, sign acknowledgements for the amounts of articles received by the Trust and prepare monthly and yearly statements of revenue and expenditure, as well as, the register of assets of the Trust and place them before the Board of Trustees for their approval.

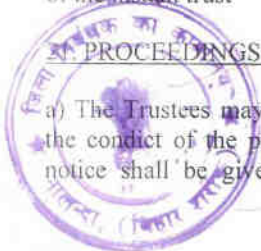
The Treasurer may be authorized to sign bank cheques, application for drafts and payment instructions jointly with any of Trustee In special case and circumstances only. The Treasurer is responsible for safe custody of cash, bonds, securities etc. of the Trust.

c. ONE DIRECTOR (SPOKES PERSON)

One of the trustees who is to be called as spokes person would discharge the duties & responsibilities as conferred by the board of trustees to meet/ liaison /converse either the government officials or the non-government officials or the public spirited such individuals committed for the society. By doing so, he would always keep in mind the object & reasons of the instant trust

PROCEEDINGS OF THE TRUSTEES:

a) The Trustees may meet as often as may be necessary for the conduct of the proceeding of the Trust. At least 7 days notice shall be given for every meeting of the Board of

19. ADMINISTRATION OF THE TRUST:

The administration of the TRUST shall vest with the Board of Trustees, which consist of:

- a. One Chairman (Managing Trustee)
- b. One Secretary cum Treasurer (Deputy Managing Trustee)
- c. One Director (Spokes Person)
- d. The enforcement Board of the Trust is to consist all the trustees popularly called as Directors collectively for specific cause and reasons.

20. ROLES . RESPONSIBILITIES & POWERS:

The Roles, Responsibilities and powers of all these officers are defined below. In addition to these, the Managing Trustee may grant additional roles, responsibilities and powers to the Trustee.

a. CHAIRMAN (MANAGING TRUSTEE):

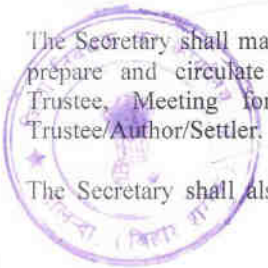
In addition to discharging normal duties of a trustee, the Managing Trustee shall co-preside over meeting of the Board of Trustees. The Managing Trustee is authorized to sign all documents, including bank documents, acknowledgements for the contributions received, and agreements with individuals, Government Institutions and other organizations, on behalf of the board of trustee in absence of secretary of the trustee.

The Managing Trustee is responsible for ensuring that the Trust pursues its objects and for maintaining the dignity of the Trust organization and shall use his/her influence to promote the activities of the Trust.

b. SECRETARY CUM TREASURER (Deputy Managing Trustee): Under Role of Secretary

The Secretary shall maintain the records of the organization, prepare and circulate agenda and minutes of Board of Trustee, Meeting for the approval of the Managing Trustee/Author/Settler.

The Secretary shall also be responsible for the day to day

Trustees, provided however that the Chairman of the Trust shall have power to convene a meeting at shorter notice for transacting any proceeding considered by him to be urgent

b) The meeting of the Trust shall be presided over by the Author/Settler of the Trust and in his absence or inability, by the Managing Trustee.

c) The Proceeding of the Trust may also be transacted by circulation of *papers*.

22. ACCOUNTS. ACCOUNTING YEAR AND MINUTES:

The Board of Trustees shall duly maintain true and correct accounts of all assets, disposals, receipts, expenses and liabilities of the Board of Trustees. The year of Account of the Trust shall be from first of April to 31st of March succeeding. It shall be open to the Trustees to change the year of account, if they find it more convenient to do so.

23. BANK ACCOUNTS:

The Trust may open Bank accounts in the name of Trust in such Bank/s as the Trustees may decide and provide for its operation from time to time. Any two of the three trustees would be authorized signatory to operate the bank account and in special case only the treasurer may be associated for bank operation for a limited period and time only.

24. OPERATION OF PROCEEDING:

Any Trustee authorized by the Board of Trustees may bring all actions in the name of Trust and represent the Trust in all legal proceedings anti also represent the Trust and defend proceedings against the Trust.

25. DELEGATION:

The Board of Trustees may, from time to time, delegate to one or more of their body or any other person or committee/s such of their powers and duties as they deem fit subject nevertheless, to their retaining the ultimate control and supervision.

26. FRAMING OF RULES AND BYE-LAWS:

The Board of Trustees may frame Rules and Bye-laws for the management of Trust, its institutions, properties and proceedings of the Trustees, and amend or rescind them as it deems fit, from time to time, provided however, that such Rules & Bye-laws shall not be repugnant to the provisions of Section 2(15) and Sections 11 to 13 and Section 80 G of the income Tax act, 1961 and shall not be given effect to without the prior approval of the jurisdictional income Tax Authority.

27. INDEMNITY:

The Trustees shall be kept indemnified and harmless by the Trust against any action, claim, demand or liability arising against them, for anything done by them in good faith, pursuant to the POWER and AUTHORITY vested in them under these presents,

28. AMENDMENT OF THE TRUST DEED:

The Provisions of this Deed may be amended by the Board of Trustees. It is hereby made clear that the Board of Trustees shall have power to make, from time to time, all such amendments as may be required to secure recognition, registration, exemptions and relieves under the Income Tax Act or other fiscal laws, or as may be found necessary for the smooth working of the Trust. But, no amendment shall be made which is repugnant of Section 2(15), Sections 11 to 13 and Section 80 G of the Income Tax Act, 1961 and the same shall not be given effect without the prior approval of the jurisdictional Income Tax Authority, provided that the character of this Trust as a Public Trust shall not be altered. In no case the vision, goal, mission and object of the instant trust can be changed and modified. However, if required and needed, the further object may be added or supplanted by the board of the trustee for the sake of the trust.

29. DISSOLUTION OF THE TRUST:

This Trust is irrevocable. If for any reason, the trust is to be dissolved or to be wound up, then the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees but the same shall be transferred to another such Charitable Trust, Society, Association or Institution whose objects are similar to those of this Trust and which enjoys recognition under Section 80G of the Income Tax Act, 1961.
